

ORDINANCE NO. 96 - 20

AN ORDINANCE OF POLK COUNTY, FLORIDA, RELATING TO THE POLK COMMERCE CENTRE COMMUNITY REDEVELOPMENT AGENCY (CRA); AMENDING ORDINANCES NO. 92-40 AND NO. 92-45 TO ESTABLISH THE CRA BASE YEAR AS 1993; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the County Commission of Polk County, Florida, has adopted Ordinance 92-40 creating the Polk Commerce Centre Community Redevelopment Agency (CRA) and Ordinance 92-45 establishing the CRA Trust Fund; and

WHEREAS, the aforementioned Ordinances were adopted on November 24, 1992 and December 22, 1992, respectively, after the County tax rolls for 1992 were completed and certified; and

WHEREAS, it is necessary to establish the appropriate base year for the CRA which can be certified;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF POLK COUNTY, FLORIDA;

SECTION ONE: The County Commission does hereby expressly amend Ordinance 92-40 to add the following as Section 6 and Ordinance 92-45 to add the following as Section 13:

The base year for all purposes specified or required under the Florida Community Redevelopment Act, Florida Statutes, Chapter 163 shall be 1993.

SECTION TWO: Effective Date.

This ordinance shall become effective upon receipt of the official acknowledgment from the Office of the Secretary of State of Florida that this Ordinance has been filed with said office.
